I am happy that most of the issues regarding our welfare and entitlements as insurance and transport have been clarified to us. I thank you the PS/SJ for this clarification.

I would like to once again thank the Hon. Chief Justice for the visionary leadership he is providing to the Judiciary.

I wish to specially thank your Lordship, Deputy Chief Justice Emeritus, Retired Justices and Judges for attending this Conference with us from start to end. Your attendance gives us the courage to move on. Thank you once again for being with us.
