22 Judicial Officers Transferred

KAMPALA-7 June 2017: At least 22 judicial officers at different levels have been transferred in a bid to fill gaps in some courts and improve service delivery.

The transfers are also intended to rotate officers who have stayed in their stations for more than two years and to place others in appropriate stations.

According to Administrative Circulars issued on 7th June 2017 by the Principal Judge, Dr. Yorokamu Bamwine and the Chief Registrar, Mr. Gadenya Paul Wolimbwa, the new transfers were done in consultations with the Hon. the Chief Justice.

The redeployment of judges in the various High Court Divisions and Circuits is to take effect from 15th August 2017. "They are subject to completion of any part-heard cases in advanced state at the current station and the pending judgments and rulings as per the recommendation of the Case Backlog Reduction Committee," Dr. Bamwine's Circular read in part.

All the magistrates' transfers are effective 1st July 2017, according to Mr. Gadenya, whereas Mr. Muse Musimbi, the only transferred registrar, will take up his new posting on 12th June 2017 "to allow him time to prepare for his retirement in the last half of the year".
