REPORT TO THE JUDGES CONFERENCE ON THE PROGRESS ON PROCUREMENT FOR THE CONSTRUCTION OF THE JLOS HOUSE

The sector is proceeding with the procurement for the construction of the JLOS House using PPP (build operate and transfer) venture following recommendation of the Ministry of Finance Planning and Economic Development.

The JLOS PPP Project will have three components, namely the JLOS Towers Premises (housing a number of JLOS Institutions including the High Court, the Ministry of Internal Affairs, Uganda Prisons Service, Ministry of Gender, Labour and Social Development, among others), the Appellate Courts Premises, and the Police Headquarters Premises (containing the headquarters of the Uganda Police Force). The JLOS PPP Project will provide 102,000 square meters of office space for the following institutions: Police Headquarters; Appellate Courts; purpose built High Court House; Ministry of Justice and Constitutional Affairs; Ministry of Internal Affairs; Police Headquarters; Uganda Prisons Services; Uganda Registration Service Bureau; Directorate of Public Prosecutions; Uganda Law Reform Commission; CADER; Tax Appeals Tribunal; Judicial Service Commission.

To support the process, the sector sought guidance from PPDA and the privatization unit of the Ministry of Finance, on how to proceed in accordance with the requirements of the PPDA Act and the PPP policy.

The sector established a multi-sectoral Transaction Advisory Committee chaired by the Director Legal Advisory Services (MoJCA) with members drawn from the Ministry of Finance, the Privatization unit, the Judiciary, the JLOS construction committee, the Ministry of Works and Transport and the Ministry of Lands, Housing and Urban Development.

A two stage procurement process involving a request for expression of interest and a request for proposal from shortlisted firms at expression of interest stage was adopted.

The consultants contracted to prepare the detailed designs, submitted the detailed designs and Bills of quantities that will be an integral part of the request for proposals (RFP).

A call for expression of interest (EOI) from companies or consortia to review the designs, procure, finance construct the JLOS house and provide facilities management services was advertised on 12th June 2014 and the following companies responded.

The sector will have to undertake thorough due diligence firms that will submit bid bonds since it would be expensive to conduct a due diligence on all shortlisted firms.

The sector also recruited three advisors on a short term basis to support the JLOS house transaction advisory committee to prepare the necessary documentation required for request for proposal and also to provide technical support in evaluation of proposals to choose the best evaluated bidder. The advisors are people with PPP technical, legal and financial expertise and skills.

The Transaction Advisory Committee with support from the transaction advisors is prepared the necessary documentation and draft agreements that were issued at the request for proposal stage. Request for proposals were issued to shortlisted firms by 19th Jan 2015. Below are some of the critical activities and timelines for your information-
