Aggrieved by the arbitrary decision of DFCU Bank, the applicant filed Civil Suit No.13 of 2023 in the High Court Commercial Division against DFCU Bank seeking damages to the tune of 10,000,000,000 for breach of contract. The said suit has overwhelming chances of success and still pending hearing.8. As a result of termination of the contract for sell of the 1st respondent's property by DFCU Bank, the applicant caused and held a series of meetings with the executive members of the 1st respondent and DFCU Bank about recovering his damages.
