Some time back in 2004 Kampala City Council predecessor of the Defendant had a dispute with a one Alnasir Gulama Hussein over a piece of land known as the Old Taxi Park.</p> <p>6. Kampala City Council had leased or given the land known as Old Taxi Park to the said Alnasir Gulama Hussein to develop land known as the Old Taxi Park into a modern parking lot and for some reasons the arrangement did not materialize leading into a civil dispute between the two parties.</p> <p>7. The dispute between Kampala City Council and Alnasir Gulama Hussein culminated in Civil Suit No. 1687 of 2000 - A.G Virani Vs K.C.C wherein the plaintiff A.G Virani laid interest in the land known as the 'Old Taxi Park' and would later obtain an injunction restraining Kampala Capital City authority from dealing with the 'Old Taxi Park' land until he was fully compensated by K.C.C for which ever damages and inconvenience it had caused.</p> <p>8. The plaintiff avers that K.C.C would later subdivide the 'Old Taxi Park' piece of land into several plots with the intention of sub leasing the several plots to several developers and investors to erect commercial building and parking lots having fallen out with Alsanar Gulama Hussein. See subdivision annexure A1.</p> <p>9. The Plaintiff avers that K.C.C invited bidders to apply for sublease on the subdivided plots of land. Minutes of meeting of K.C.C to consider application for leases is annexure "A".</p> <p>10.
