(2) Consequent to (1) above hereto, the Respondents be ordered to purge themselves of the contempt by immediately restoring the status Quo of the suit land by re-planting all the tress and replace the wire mesh fence on the suit land (3) The contemnors be further punished by imposition of a heavy penalty as court may deem fit. (4) The contemnors be ordered to pay (17,000,000) Seventeen Million as damage of property destroyed during the invasion of the suit land, threats, inconvenience and torture occasioned by the Applicant. (5) The Respondents being contemnors be in addition to the above, committed to civil prison a period this honorable court deem fit. (6) Costs of this application be paid by the respondents.
