The defendants purported to sell to the plaintiffs the suit registrable interest covering the plaintiff's kibanja. Following payment of the agreed consideration, the defendants through their agent proceeded to survey and subdivide the land after which they handed over a duplicate certificate of title for the land comprised in Kyadondo Block 98 Plot 99 to the plaintiffs duly registered in their name. The boundaries of this ;and corresponded with the plaintiffs' kibanja.</p> <p>Later, it was brought to the plaintiffs' attention that part of the land shown to them by the defendants was seated on a third party's land. Subsequent inquiries made by the plaintiffs revealed several scandalous irregularities and fraud in the survey, mutation and transfer process.</p> <p>The irregularities were brought to the defendants' attention and the parties entered into a memorandum of understanding in a bid to resolve the legal issues that had arisen.</p> <p>Despite repeated reminders, the defendants have continued to breach the memorandum of understanding.
