Its contended that the 1st defendant fraudulently transferred the suit properties to the 2nd ,3rd and 4th defendants after the determination of civil suit no. 99 of 2015 which revoked the letters of administration that were formerly granted to the 1st defendant and were replaced them by joint grant to the plaintiffs and the 1st Defendants 4. Its further contended that the certificates of title were transferred to the 2nd, 3rd and 4th Defendants respectively without payment of any consideration to the Plaintiffs as the administrators and beneficiaries of the estate . 5.The plaintiffs contend that the 2nd, 3rd and 4th Defendants illegally transferred the certificates of title into their names when the 1st defendant's grant of letters of administration had already been cancelled and replaced by a grant to the plaintiffs and the 1st defendant dated 22nd May 2022 and	For Mention	Assistant Registrar 3
