Around early 2020 the defendants led by the first defendant connived and trespassed on the plaintiff's land, erected thereon illegal structures and started cultivating crops thereon. The 2nd to 15th defendants are currently in occupation of part of the suit land alleging that there are the rightful owners thereof having bought different portions from the 1st defendant; and all the pleas for them to vacate the suit land have been futile.
