The facts constituting the plaintiff's cause of action arose as hereunder indicated:</p> <p>(i) Between the year 2014 and 2015, the plaintiff purchased from the defendant land comprised in Bulemezi Block 794 Plot 14, 17, 19, 20 and 29; and Bulemezi Block 292 Plot 203,242, 243 and 245 (proof thereof and agreements are attached hereto and marked as Annexure "A1", "A2", "A3", "A4", "A5", "A6", "A7" and A8).</p> <p>(ii) The defendant handed over certificates of title for land comprised in Bulemezi Block 292 Plot 203 and Bulemezi Block 794 Plot 17 all of which were not registered in his names but promised to facilitate the process of effecting direct transfer into the Plaintiff's names.(Copies of the certificates of title are attached hereto and marked B1 and B2)</p> <p>(iii) The Defendant also handed to the Plaintiff transfer forms purportedly signed by the registered proprietors from whom he claimed to have purchased the aforementioned land.</p> <p>(iv) The Defendant promised to deliver vacant possession and other titles for the above suit land after mutation of the same.</p> <p>(v) Despite several reminders, the Defendant has adamantly refused to give vacant possession, deliver the remaining titles and facilitate the transfer of the suit land into the plaintiff's name.</p> <p>(vi) The plaintiff recently learnt that defendant has now applied for special certificates of title in respect of the suit land, subdivided the suit land and he is illegally selling and fraudulently transferring part of the suit land to other people in order to defeat the plaintiff's interests in the suit land.</p> <p>5.
