AWARD TO THE HON THE PRINCIPAL JUDGE BY THE MASINDI DISTRICT COUNCIL

On the 30th September 2014, the Judiciary of Uganda was in the limelight, and this time for all the good reasons.

The Masindi District Council, in a rare motion, moved to recognise, the Hon Principal Judge of Uganda, Hon Dr Justice Yorokamu Bamwine for showing exemplary leadership and demonstrably 'immeasurable judicial services' to the people of Masindi District. The motion, which was moved by Hon Mugabi Badru, was unanimously approved by the majority of members of the Masindi District council, in a session dated 30th September 2014. The approval of the motion was followed by the award of **Certificate of Recognition** to the Hon Principal Judge.

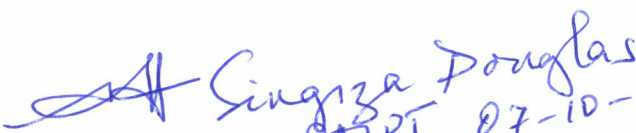
