Judiciary deploys newly appointed Judicial Officers, transfers 45

The Judiciary has deployed 25 newly appointed Judicial Officers and transferred 45 at the rank of Registrars and Magistrates in a bid to improve efficiency and effectiveness in service delivery at various Courts across the country.

The Hon. Chief Justice, Alfonse Chigamoy Owiny – Dollo welcomed the deployments and transfers noting that they are part of the Judiciary's Transformational Agenda that focuses on enhancing access to justice and fighting case backlog. "We are continuing with our agenda of bridging the gap between we the justice providers and the justice seekers by taking Court services closer to our people. We will continue to build more Courthouses, employ more personnel, and provide modern tools of work in the Courts as we fulfill our vision of justice for all," observed the Chief Justice.

While releasing the list, the Chief Registrar, Her Worship Sarah Langa Siu, noted that some of the deployments and transfers at the Magistracy level are in new Magisterial Areas. "Some of the deployments and transfers are in new Magisterial Areas where the Judicial Officers will pioneer. Our appeal to them is to execute their duties with diligence, integrity and maintain a people centered approach that has been our theme for the year. In regard to the transfers, these are normal and intended to improve service delivery," she said.

Some of the new magisterial areas that have been operationalized include Nakaseke, Gomba, Butaleja and Kawempe.

The deployments and transfers have seen stations with high caseloads considered and added more Chief Magistrates. Such areas include Mukono, Mbarara and Buganda Road. Buganda Road Court which started handling civil matters has had an additional Chief Magistrate, sitting at the Law Development Centre, deployed. It is hoped that this deployment will also offer professional support and mentorship to students at the Centre.

The Chief Registrar, urged the Judicial Officers to commit to serve the public and avoid all forms of maladministration. Newly appointed Acting Chief Magistrates, Kwesiga Joseph and Ndagire Patricia have been deployed to Nakaseke and Kaberamaido respectively.

The changes have also seen Deputy Registrars; Catherine Agwero being moved from Kabale to Luwero; Mulalira Faisal Umar (Judicial Training Institute to Masindi); Assistant Registrars; Atigo Hellen (Family Division to Rukungiri), Nantamu Oliver (Rukungiri to Family Division), Nakitende Juliet moves from Masindi to the Judicial Training Institute while Tumwebaze Kenneth has been moved to Kabale.

The Chief Registrar explained that the new deployments are effective immediately while the transfers will be effective on January 1, 2025.
