However around 1978, Yakobo Sebuliba, one of the children of the Late Aliwaali family land colluded with his son named Kayongo William (also the 1st Defendant's father) and acquired the mailo interest from the registered mailo owner. The above acquisition notwithstanding, the Aliwaali family continued to utilize the suit land was their family burial grounds while some of his children such as Philomela Nakayiwa continued to reside on the same land until her death sometime in 2011. The Plaintiffs therefore aver and contend that the registration of the suit land into the names of Yakobo Sebuliba and Kayongo William did not in any way affect the equitable interests of other family members and descendants of the Late Aliwaali including the Plaintiffs who still have interest in the suit land.
