(Copy of the letter is hereto attached and marked *C')</p> <p>d) The IGP in a letter referenced OPS: 176/414/01 Vol:65 responded to the event's organizers with directives to which the Plaintiff complied with including payment of non-tax revenue.</p> <p>e) To ensure proper organization and security of the event, the Regional Police Commander, Kampala South and the District Police Commander, Entebbe were informed of the concerts and requested to provide the necessary security as directed by the Inspector General of Police.
