The Applicants have filed and served their Notice of Appeal, applied for a certified record of proceedings and judgment, and have since lodged the Record of Appeal in the Court of Appeal; the appeal is competent and pending. 4. The intended appeal raises serious and substantial questions of law and fact which have a high likelihood of success and merit the consideration of the Court of Appeal. 5. Notwithstanding the pendency of the appeal, the 1st Respondent has commenced execution by way of Miscellaneous Application No. 0537 of 2026 seeking a garnishee order against the 2nd Applicant's bank account, which application is fixed for hearing on 29th June 2026. 6. The 2nd Applicant is a financial institution licensed and regulated by the Bank of Uganda, and the attachment of its accounts by way of garnishee will gravely disrupt its banking operations and occasion it substantial and irreparable loss. 7.
