On 27th February 2017, the Plaintiff and the Defendant entered into a tenancy in which the Plaintiff agreed to let office space at Social Security House to the Defendant. Under the terms of the Tenancy Agreement, the Defendant had an obligation to pay rent quarterly and in advance. The Defendant defaulted on its obligation to pay rent and consequently became indebted to the Plaintiff in rent arrears. The Plaintiff issued several demand notices and remainders to the Defendant to pay the outstanding rent arrears which the Defendant responded to with undertakings to pay which were never honoured. (Photocopies of the correspondences between the Plaintiff and the Defendant are attached hereto and marked as Annexure "C") On 16th September 2019, the Plaintiff issued a demand notice for the rent arrears which at the time stood at UGX 36,065,971 (Uganda Shillings Thirty-Six Million Sixty-Five Thousand Nine Hundred Seventy-One Only) for the period of 5th October 2017 to 16th September 2019. On 20th December 2019, the Plaintiff and the Defendant entered into an agreement for payment of the outstanding rent arrears in 6 (six) instalments of UGX 6,010,995 (Uganda Shillings Six Million Ten Thousand Nine Hundred Ninety-Five Only) for the period of 18th January 2020 to 18th June 2020.
