The learned trial Chief Magistrate erred in law when she disregarded or failed to give evidential value to the documentary exhibits produced by the Appellant, namely the kibanja sale agreement of 15th February 2016 (PEX1), the acknowledgment of receipt of balance of 25th May 2016 (PEX2), the certified copy of the certificate of title (PEX3), and the busuulu/ground rent receipt of 20th January 2017 (PEX4), each of which corroborated the Appellant's lawful acquisition of the kibanja interest and payment of annual rent to the registered proprietor then in office. 2.The learned trial Chief Magistrate erred in law and fact when she failed to properly evaluate the totality of the evidence on record, and in particular failed to give due weight to the corroborated, credible and unchallenged evidence of PW1 (the Appellant), PW2 (Ssalongo Micheal Mukasa Kasawuli, the very registered proprietor who sold the kibanja and who testified in support of the Appellant's claim), and PW3 (Kaggwa Tom, the witness to the sale transaction), thereby arriving at a decision that was against the weight of the evidence as a whole. 3. The learned trial Chief Magistrate erred in law and fact when she failed to properly apply and give effect to Article 237(8) of the Constitution of the Republic of Uganda, 1995 and Section 29(1)(b) of the Land Act, Cap. 227 (as amended), which protect the security of occupancy of lawful and bona fide occupants of mailo land, including kibanja holders such as the Appellant who entered upon and developed the suit land with the consent of the then registered proprietor.
