The CRC, chaired by the 10th Respondent, comprises individuals directly involved in the pending suits, creating conflicts of interest and undermining judicial authority. Its publication on KH3 social media platforms magnifies prejudice by presenting matters under litigation as subject to parallel nonjudicial determination. (4) As a result, the Applicants have suffered threatened compromise of their claims, additional legal costs, mental anguish, and erosion of confidence in the judicial process.
